Lo mhlahlandlela ubhalwe futhi usatshalaliswa yikhomishini i-Broad-Based Black Economic Empowerment Commission (“B-BBEE Commission”) ngenhloso yokuhlinzeka ngomhlahlandlela mayelana nezokuphathwa kwamabhizinisi asaqala (Start-up Enterprises) ngokwemithetho ye-B-BBEE Codes of Good Practice eshicilelwe ngokuhambelana nomthetho i-B-BBEE Act.

Ibhizinisi Elisaqala (Start-up Enterprise) Kanye ne-B-BBEE

Imithetho ama-Codes of Good Practice achaza amabhizinisi asaqala njengamabhizinisi asaqala ukusebenza noma izinkampani ezibhaliswe ngokusemthethweni esezisebenze isikhathi esingaphansi konyaka, okuyinto ehlukile kokujwayelekile lapho izinkampani zingathathwa njengezintsha kuze kube yisikhathi esiyiminyaka ephakathi kwemithathu nemihlanu. Amabhizinisi asaqala (Start-up Enterprises) akalwa njengama-Exempted Micro-Enterprise (EME) ngokubekwe kuma-Codes Series 000 onyakeni wokuqala olandela ukusungulwa noma ukubhaliswa kwawo.

Ama-EMEs awadingi ukuba ahlolwe ngaphansi kohlelo lokuqinisekiswa kwemininingwane okwenziwa yizinkampani ezijutshelwe lo msebenzi kodwa alindeleke ukuba abhale izincwadi ezifungelwe ezisuselwe endleleni enikwe njengesibonelo ku-www.thedti.gov.za ukuqinisekisa lokhu okulandelayo:

Ukubekwa ezingeni okuzenzekelayo ezinkampanini ezntsha ezingama-EME

Ngaphezu kwezibonelelo ngokohlelo lokuqinisekiswa olubalulwe ngenhla, i-EME enabanikazi abangama-51% abamnyama ingakwazi ukukhushulelwa ezingeni “Labaneqhaza Abasezingeni Lesibili” (“Level Two Contributor”) ibe nokwamukelwa okuyizinga lama-125% le-B-BBEE, I-EME, enama-100% obunikazi obumnyama ingakhushulelwa ezingeni “Labaneqhaza Abasezingeni Lesibili” (“Level Two Contributor”) ibe nokwamukelwa okuyizinga lama-135% le-B-BBEE.

Okuyizidingo ngqo kwezinkampani ezisaqala kumathenda/izinkontileka/namanye amathuba ezomnotho

Ngale kwalokhu okubaliwe ngenhla kwezibonelelo nezinga elikhulisiwe lama-EME kanye nezisaqala (Start-up Enterprises), kufanele zithumele ama-Qualifying Small Enterprise (“QSE”) uma zifaka izicelo zamathenda, noma zifuna ukwenza noma yini kwezomnotho okubalulwe ngokwesigaba u-Section 10 (1) somthetho i-B- BBEE Act, Eziyizigidi eziyi-R10 kodwa ngaphansi kweyizi-R50, nezinkontilaka eziyizigidi ezingama-R50 nangaphezulu kufanele zithumele isilinganiso esijwayelekile lapho kunesidingo khona.

Lokhu kusho ukuthi inkampani esaqala izodinga isiqinisekiso esenziwe yinkampani egunyaziwe eyenza lokho futhi ukwethulwa kwalesi silinganiso kususelwe kwimininingo yangonyaka.
