

Iyini iKhomishana ye-B-BBEE?

IKhomishana i-Broad-Based Black Economic Empowerment (B-BBEE) Commission (“iKhomishana ye-B-BBEE”) isungulwe njengenhlango ngaphakathi kokuphathwa koMnyango Wezohwebo, Ezezimboni NezokuQhudelana Kwezohwebo (“i-dtic”) ngokweB-BBEE Act.

Iyini i-Exempted Micro-Enterprise?

Ibhizinisi elingeniso yonyaka eyi-R10 Million noma ngaphansi lifaneleka njenge-Exempted Micro-Enterprise (i-EME).

Ukufaneleka njenge-Exempted Micro-Enterprise

I-EME ithathwa njengeneSimo se-B-BBEE “Sonikelayoi Wezinga Lesine” enezinga lokwamukelwa le-B-BBEE lika-100%.

Ngaphandle kwalokhu okungenhla, Amakhodi Enqubonhle achibiyelwe ahlinzekele izinga lokuqashelwa elithuthukisiwe le-B-BBEE le-EME lapho:

- I-EME, okungenaniokungabamnyama abangu-100% ifanelekela ukhushulelwa “kwi-Level One Contributor” eyamukelwayo le-B-BBEE lika-135%.
- I-EME, okungenani engama-51% yabamnyama ifanelekela ukhushulelwa “kwi-Level Two Contributor” enezinga elamukelekile le-B-BBEE lika-125%.

Nokho, i-EME ivunyelwe ukuthi ikalwe ngokwekhadi lokuklelisakolo le-Qualifying Small Enterprise uma ifisa ukukhulisa amaphuzu ayo futhi iye ezingeni eliphezulu.

Yiziphi izidingo ze-Exempted Micro Enterprise?

I-EME ayidingi ukuqinisekiswa, kungaba yisikhulu esinezibalo noma uchwepheshe wokuqinisekisa.

I-EME idingeka kuphela ukuze uthole i-afidavithi efungelwe (isifanekiso ku-www.thedti.gov.za) noma Isitifiketi SeKhomishana Yezinkampani Nobuhlakani (i-CIPC) minyaka yonke, eqinisekisa lokhu okulandelayo:

- IsambaSengeniso Yonyaka Eyizigidi ezi-R R10 millionn omangaphansi
- Izinga lobunikazi labantu abamnyama

Ngakho-ke, akekho umuntu, uchwepheshe wokuqinisekisa, i-ejensi noma umcwaningi mabhuku onegunya ngaphansi Kwezimiso Zenqubonhle ezibuyekeziwe ukuze akhiphe i-EME nesitifiketi se-B-BBEE njengoba lokhu kuyobe kuphambene noMthetho we-B-BBEE futhi kungaholela ku-B-BBEE. Ikhomishini ithathela laba abenzi balo mkhuba ongagunyaziwe nongekho emthethweni. Akunangqondo ukuthi uchwepheshe wokuqinisekisa noma i-ejensi egunyazwe yi-SANAS, akekho ovunyelwe ukukhipha leso sitifiketi kuma-EME.
